

Minutes of Greenville Town Council Meeting December 12th, 2016

Council President Greg Redden called the regular monthly meeting to order. Other Councilpersons present were David Moore, John Braham, Keith Johnson, and Darryl Kepley along with Clerk Jack Travillian. Also attending the meeting were Water Superintendent Steven Schmitt and several concerned citizens. The meeting was opened with a prayer from Pastor Mark Avery followed by the Pledge of Allegiance.

Minutes: The minutes for November 14th regular meeting was discussed. Motion was made by Councilman Moore and seconded by Councilman Johnson to accept the proposed minutes. Motion passed 5-0.

Marshal Report:

Marshal Craig reported that Fire King has donated a security safe for keeping evidence and equipment in better secure situation. The council praised the Marshal's department for the very professional appearance and activity. The Marshal thanked the council for all the support during the year.

Financial:

Review/Approval Checks and Expenditures: Clerk Travillian presented the forms for the checks written from the utilities and the town. The checks were approved without objections.

Committee Reports:

Streets and Roads:

Councilman Kepley reported that the new culvert is scheduled to be install on Pekin Road on December 3, 2016.

Snow Plowing: The council renewed the snow plowing by Wright Construction, and wanted Councilman Kepley to give him directions about what parts of Heritage Springs streets are covered by section 1 that is the responsibility of the Town. The council also asked Superintendent Schmitt to make sure the Water Company vehicle was ready in case of extra protection being needed.

Public Relations: Councilman Braham has made an appearance at the Greenville Township Fire Station for their resent open house.

Town Attorney: Town Attorney needs to be replaced as soon as possible. Council President Redden will communicate with former town attorney Rick Fox and see if he has any recommendations. There was no update on the property purchase or the citation for the property on Harrison Street and 6th Street.


