

MINUTES OF GREENVILLE TOWN COUNCIL MEETING OF DECEMBER 12, 1995.

The regular monthly meeting of the Greenville Town Council was called to order by President Robert Williams with Councilmembers Ray Gibson and Janet Riggs and Clerk Treasurer Jack Sprigler in attendance.

Also attendance was Mike Receiver, G. Gesenhues, Jr., David Moore, Gary Getrost and Janice Gibson.

At 8:05 P.M. Council approved and passed unanimously Transfer Ordinance No. 2.

Council approved claims for the Town/Utility and Minutes of the November Meeting.

Approved extending current pay for officials and employees to Feb. 28, 1996. (3-0)
The Clerk Treasurer's report indicate bank balances are correct.

Council approved (3-0) annexation of property of D. Cristiani not previously in the Town, & Knable & Libs property' both by petition.

Council also gave preliminary approval for alley vacation requested by V. Fessel POA for Travillian property located along U.S. 150.

Attorney G. Gesenhues advised the Council that the two (2) Council seats approved at the November election would be three (3) year terms for 1996, 1997, and 1998, with an election to be held in 1998.

Council noted that since the increase had been approved Council moved to appoint Ted Miller and G. Burkhart to the three (3) terms, thus expanding the Council to five (5). On vote of Council, these appointments were approved (3-0).

Each Councilmember waived the right to receive the customary ten (10) day Notice of the vacancy as required by law.

President Robert Williams motioned the Council dissolve to current Utility Advisory Board, 2d by Councilmember Ray Gibson; unanimously approved (3-0).

Council, in appointing the two individuals noted that the seats wre At-large and effective January 1, 1996.

Council accepted a Conflict of Interest Disclosure Statement from Ray Gibson, Councilmember.

Mr. Gesenhues stated that the final closing on the sale of the lake property should be extended to allow for final survey/abstract work-up. Council noted that there is a discrepancy with the survey/abstract and that this must be cleared up before closing can be made. Council approved the extension for the time required to clear up the matter.

No further business coming before the Council, Ray Gibson motioned for adjournment, seconded by Robert Williams.

TRANSFER ORDINANCE NO. 1995.02

TITLE: AN EMERGENCY ORDINANCE PROVIDING FOR THE TRANSFER OF APPROPRIATIONS FOR THE TOWN OF GREENVILLE, FLOYD COUNTY, INDIANA FOR THE YEAR 1995 AS REQUESTED AND FORWARDED TO THE TOWN COUNCIL FOR THEIR ACTION AND PASSAGE PURSUANT TO IC 6-1.1-18-6.

WHEREAS, certain extraordinary conditions have developed since the adoption of the existing annual budget for the year 1995 and it is now necessary to transfer appropriations into different categories than was appropriated in the annual budget for the various functions of the several departments to meet the emergencies.

Section 1. BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, FLOYD COUNTY, INDIANA, that for the expenses of the Town of Greenville Government, the following appropriations are hereby transferred and set apart out of the funds hereinafter named for the purpose specified, subject to the laws governing the same, such sums herein transferred unless otherwise stipulated by law.

Section 2. Where it has been shown that certain existing appropriations have unobligated balances which will be available for transferring as follows:
