THIS INDENTURE WITNESSETH, that:

WHEREAS, Mr. & Mrs. Roy Kessinger filed a Petition with the Town Council of the Town of Greenville requesting the vacation of a certain unimproved alley lying between lots 3,4,34,33 on the north and lots 5,6,43,44 on the south, between U.S. 150 and Clark Street, Plat 143 and Plat 134, NW 1/4, Sec. 5, T2S, R5E, West 1/2 of N.E. 1/4, Sec. 5, T2S, R5E in the Town of Greenville; and,

WHEREAS, Notice of the filing of the Petition was given on the 12th day of April, 1994, and on the 27th day of April 1994 said notice appeared in the New Albany Tribune, newspapers having general circulation and published in Floyd County, Indiana, said notice establishing the 10th day of May 1994, at 6:00 p.m., local time, in the Town Hall, in the Town of Greenville, Indiana, as the time and place of the hearing upon said Petition, and,

WHEREAS, the hearing on the Petition of Mr. & Mrs. Roy Kessinger for the vacation of referenced unimproved alley was duly held and all recommendations, suggestions, and criticisms were given careful study and consideration by the Town Council of the Town of Greenville, Indiana.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL of the Town of Greenville, Floyd County, Indiana, that the unimproved alley being 16 feet in width and approximately 264 feet in length, north of Lot No. 3, 4, 34, 33 and south of Lot No. 5, 6, 43, 44, Plat 143 and Plat 134, NW 1/4, Sec. 5, T2S, R5E, West 1/2 of N.E. 1/4, Sec. 5, T2S, R5E, in the Town of Greenville, more commonly known as bordering u.S. 150, E. 5th Street, Clark Street, and Providence Street (Pekin Road), be, and the same hereby vacated, such vacation being subject however, to the rights of any public utilities presently having services within the confines of the alley so vacated.

BE IT FURTHER ORDAINED, that this Ordinance shall be in full force and effect from and after it's passage by the Town Council of the Town of Greenville, Indiana.

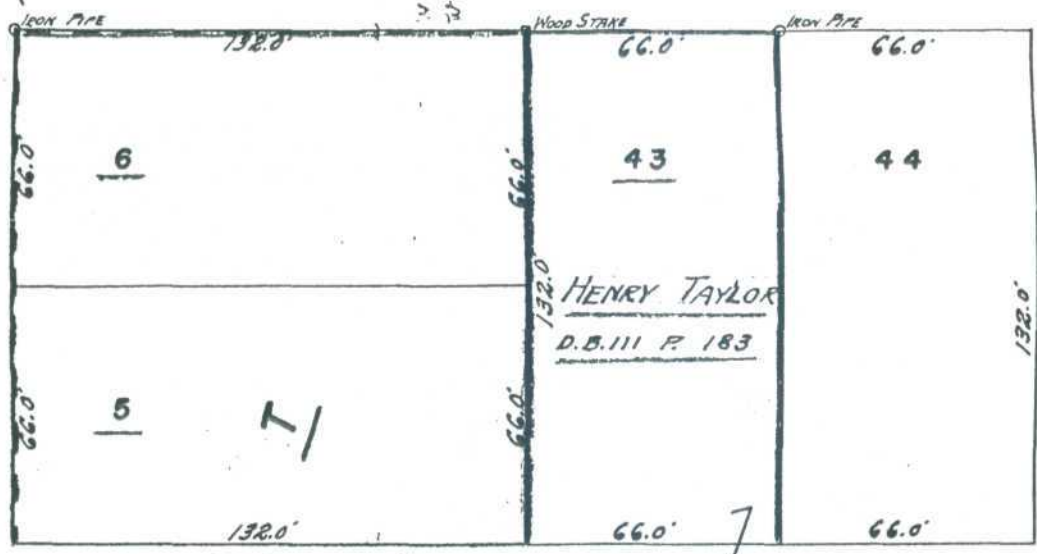

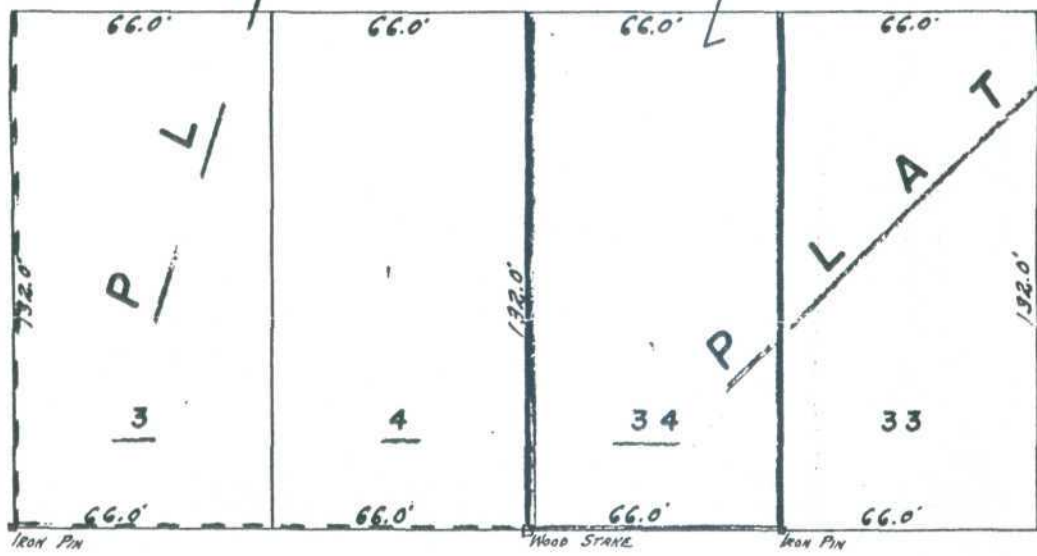
CLARK STREET 60'
