

ORDINANCE NO. 2002-T-019

AN ORDINANCE REDISTRICTING WARDS (DISTRICTS) WITHIN THE
TOWN OF GREENVILLE, FLOYD COUNTY, INDIANA

WHEREAS, the Town Council of the Town of Greenville, Floyd County, Indiana pursuant to the provisions of IC36-5-2-4.1 (a) redistricts Wards (Districts) within the Town of Greenville, Floyd County, Indiana in this calendar year of 2002 for the purposes of conducting elections of town officials; and,

WHEREAS, subject to provisions of IC 3-11-1.5-32 and IC 36-5-2-4.1 (a) redistricting shall be made in this year 2002 and every ten (10) years; and,

WHEREAS, the boundaries set forth below, consisting of three (3) Wards (Districts) are being established according to population,

NOW THEREFORE BE IT ORDAINED, that,

Pursuant to IC 36-5-2-4.1 (a) boundaries are established as follows:

WARD NO. 1: Bounded by the Corporation line to the North, South, West, and the middle of the Georgetown/Greenville Road, consisting of:

Glenn Reisert Drive (From the middle of Main Cross St.)
Clark St. (West from the middle of Main Cross St.)
U.S. 150 (West from the middle of Main Cross St. &
Georgetown/Greenville Rd.)
Harrison St. (West from the middle of Georgetown/Greenville Rd.)
Bradford Rd. (West from middle of Georgetown/Greenville Rd.)
Georgetown/Greenville Rd (From Corporation line East to
and Main Cross St. Corporation line To the South)
West 1st, 2d & 3rd Sts.
Voyles Rd. (From middle of Rd. East to Corporation line)
Wind Dance Subdv. (Annexed territory)

WARD. NO. 2: Bounded by Corporation line to the North, South, East to E. 6th St. and West to middle of Georgetown/Greenville Rd., consisting of:

Clark St. (East from middle of Main Cross St.)
U.S. 150 (East from middle of Georgetown/Greenville Rd &
Main Cross St.)
Harrison St. (East from middle of Georgetown/Greenville Rd,
to E. 6th St.)
Church St. (East from middle of Georgetown/Greenville Rd.)
Pekin Rd. (North from E. Harrison St.)
Arthur Coffman Rd. (East from Pekin Rd.)

WARD NO. 3: Bounded by the Corporation line to the north, South and East and West to E. 6th Street (From Harrison St. north to Clark St.) consisting of;

Valley View Drive
North Valley View Drive
East Valley View Drive
Beechwood Drive
Maple Drive

(All above in Parkland Heights Subdv.)
Buttontown Rd. (All that is in Town limits)
U.S. 150 (East from E.th St.)
Schuler Rd. (All that is Town limits)

One (1) legislative member for each Ward (District) to be elected at-large by the voters of the Whole Town; and, the Clerk-Treasurer shall be representative of the Whole Town and elected by the voters of the Whold Town.

Ordinance dated 14 November 1995 provides for the election of two (2) Town Council At-Large positions be elected by the Whole Town.

THIS Ordinance replaces Ordinance No. 1992-03, dated 15 December 1992.

This Ordinance shall take effect upon passage by the Town Council of the Town of Greenville, Floyd County, Indiana.
