

ORDINANCE NO. G-2001-T-15

AN ORDINANCE VACATING A PUBLIC ALLEY

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, THAT:

WHEREAS, the Town Council of the Town of Greenville desires to vacate a public alleyway located within the town boundaries; and

WHEREAS, the Town is granted the authority to vacate public ways by I.C. 36-7-3-12; and

WHEREAS, the public alleyway to be vacated is more particularly described as:

The sixteen (16) foot unimproved alley which lies between Lots 32 and 45 located within the Town of Greenville, Floyd County, Indiana.

WHEREAS, the vacated public alleyway shall be subject to any and all easements and/or restrictions of public record that may apply to the alleyway and to the real estate contiguous to it.

NOW THEREFORE BE IT ORDAINED by the Town Council of the Town of Greenville, Floyd County, Indiana, that:

SECTION I: The following described public alley located in the Town of Greenville, Floyd County, Indiana, more particularly described as follows:

The sixteen (16) foot unimproved alley which lies between Lots 32 and 45 located within the Town of Greenville, Floyd County, Indiana, is hereby vacated.

SECTION II. This ordinance shall be in full force and effect from and after its passage and approval by the Town Council of the Town of Greenville, Floyd County, Indiana and a copy of this vacation shall be provided to the Floyd County Recorder for recording and to the Floyd County Auditor.
