

ORDINANCE NO. G2002 - W - 016

AN ORDINANCE ESTABLISHING RATES AND CHARGES FOR THE USE OF AND SERVICES RENDERED BY WATERWORKS SYSTEM OF THE TOWN OF GREENVILLE

WHEREAS, the existing rates and charges for services furnished by the water utility of the Town of Greenville were initially established by Ordinance and are now inadequate to provide for the proper operations and maintenance of said waterworks.

WHEREAS, it will be necessary to increase the existing rates and charges in order to provide sufficient funds to meet the financial requirements of said water utility; and, NOW THEREFORE BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF GREENVILLE, INDIANA:

Section 1. That there shall be and there are hereby established for the use of and the service rendered by the water system of the Town of Greenville, the following rates and charges:

- (a) Customer Deposit, \$50.00
- Bad Check Charge, \$25.00
