

TOWN OF GREENVILLE ORDINANCE NO. 1997-T-05

AN ORDINANCE ESTABLISHING RATES AND CHARGES FOR SERVICES
RENDERED BY THE FLOYD COUNTY HEALTH DEPARTMENT

WHEREAS, the Town Council of the Town of Greenville is empowered, pursuant to the provisions of I.C. 36-1-3, et seq., to establish reasonable rates, charges, and fees for governmental services provided to the public; and

WHEREAS, the Floyd County Health Department has requested the establishment of fees and charges for environmental services provided by the Department, as more particularly set forth in the Fee Schedule appended and marked Exhibit "A" and made a part hereof; and

WHEREAS, upon review, the Town Council of the Town of Greenville, Indiana has determined that the scheduled fees and charges do not exceed the administrative cost of those regulatory powers to be exercised or the cost of the services to be provided by the Department; and

WHEREAS, the Town Council of Greenville is desirous of adopting by this Ordinance the Schedule of Fees to be charged by the Department for services rendered.

NOW THEREFORE:

BE IT ORDAINED, that the fees and charges set forth on the Fee Schedule appended hereto and incorporated herein be, and the same hereby is, adopted and established as the fees and charges to be levied and imposed for the various services to be rendered and performed by the Floyd County Health Department, with such fees and charges, upon collection and receipt, to be deposited by the Department as required by law.

BE IT FURTHER ORDAINED, that this Ordinance shall be in full force and effect after the date of its adoption, being the 11th day of November, 1997.
